After the trial is filled the remaining entries will be put on a waiting list in the order they were received. Two dogs per handler limit in Open. **Checks will be cashed October 8 after which no refunds will be allowed.** Nursery entries must be accompanied by a copy of the dog's registration papers in order to establish eligibility for the class. Nursery entry fee should be sent in a separate check. No substitutions or add-on's in the Nursery class. If there are not sufficient entries the class will be canceled on October 8 and your check will be returned. Payback each day in all classes except Nursery. Overall Open winner will receive a Prize in addition to payback.
