Nursery entries must be accompanied by a copy of the dog's registration papers in order to establish eligibility for the class. Nursery entry fee should be sent in a separate check. No substitutions or add-on's in the Nursery class. If there are not sufficient entries the class will be canceled on July 31 and your check will be returned. Payback each day in all classes except Nursery. Overall Open winner will receive a Prize in addition to payback.
